**Main hazards:** No significant hazard.

### 3. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** SURFACTANT O 1-10%

[Xi] R41

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be mild irritation at the site of contact.

**Eye contact:** There may be irritation and redness.

**Ingestion:** Nausea and stomach pain may occur.

**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest.

### 4. FIRST AID MEASURES (ACTION)

**Skin contact:** Wash immediately with plenty of soap and water. Consult a doctor.

**Eye contact:** Bathe the eye with running water for 15 minutes.

**Ingestion:** Do not induce vomiting. If conscious, give half a litre of water to drink immediately. If unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. Transfer to hospital as soon as possible.

**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

### 5. FIRE-FIGHTING MEASURES

**Extinguishing media:** Carbon dioxide. Water. Alcohol resistant foam. Dry chemical powder.

**Exposure hazards:** In combustion emits toxic fumes of carbon dioxide / carbon monoxide.

**Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

**6. ACCIDENTAL RELEASE MEASURES**

**Personal precautions:** Mark out the contaminated area with signs and prevent access to unauthorised personnel.

Turn leaking containers leak-side up to prevent the escape of liquid.

**Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using bunding.

**Clean-up procedures:** Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method. Wash the spillage site with large amounts of water.

**7. HANDLING AND STORAGE**

**Handling requirements:** Ensure there is sufficient ventilation of the area. Avoid direct contact with the substance.

**Storage conditions:** Store in cool, well ventilated area.

**Suitable packaging:** Stainless steel. Polyethylene.
