### 1. IDENTIFICATION OF THE SUBSTANCE / PREPARATION AND OF THE COMPANY / UNDERTAKING

**Product name:** 60% SULPHUR DISPERSION

**Use / description of product:** Vulcanisation agent Sulphur in an aqueous base

### 3. HAZARDS IDENTIFICATION

**Main hazards:** No significant hazard.

**Other hazards:** No major hazards.

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** May be irritating on prolonged or repeated contact.

**Eye contact:** Slight irritant (including mechanical irritation)

**Ingestion:** Unlikely to be harmful by ingestion.

**Inhalation:** Dust may be irritating to the respiratory tract and cause symptoms of bronchitis

### 4. FIRST AID MEASURES (ACTION)

**Skin contact:** If a person feels unwell after coming into contact with this dispersion then seek medical advice.

**Ingestion:** Wash out mouth with water and give 200-300ml warm water to drink. Seek medical attention immediately.

**Inhalation:** Remove patient to fresh air. Treat symptomatically and seek medical advice.

### 5. FIRE-FIGHTING MEASURES

**Extinguishing media:** Water. Dry chemical powder. Carbon dioxide. Foam Do not use water jet

**Exposure hazards:** Burning will produce oxides of sulphur which irritate the lungs

**Protection of fire-fighters:** Respiratory Protective Equipment (RPE) must be worn.

### 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions:** Avoid contact with skin/eyes. Do not inhale mists. Avoid ingestion.

**Environmental precautions:** Prevent contamination of drains/watercourses/vegetation. Advise police.

**Clean-up procedures:** Adsorb onto sand/earth/similar adsorbent material. Once clear, wash the spillage area clean with water and detergent.
